

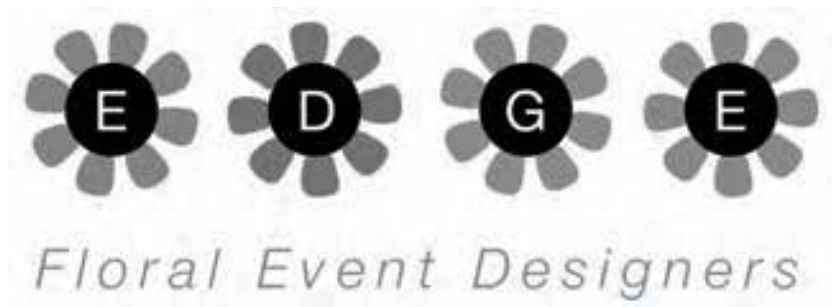
Celebrate our Honorees

Auction Rules

The governing rules of the CaringMatters Auction are as follows

All sales are final. No exchanges or refunds on auction items are permitted. Everything will be sold "as is." Please read carefully the specifications, restrictions, and limitations.

By his or her purchase, the buyer waives any claims for liability against either CaringMatters or the donor of the property or services, and neither CaringMatters nor the donor is responsible for any personal injuries or damages to property that may result from the utilization of property or services sold.

Auction Rules Continued

Unless otherwise specified, all auction items and services must be used within the time frame set out in the guidelines of each item. Unless specified, dates and times are to be arranged at the mutual convenience of the donor and the buyer. Gift certificates are not redeemable for cash.

All auction items must be paid for in full, tonight, by cash, check, or credit card. Unless otherwise specified, no returns, refunds, or exchanges are allowed. All items are non-transferable. We accept VISA, MC, AMEX, and Discover.

Silent Auction Rules

Items offered in the silent auction will have bid forms in front of each item. You may bid by simply writing your bid number on the form and the next increment you want to bid.

You do not have to take the next available bid amount. You may write in the amount you really want to bid that is higher than the next increment. The next bidder must bid a higher amount than your bid to be successful.

Most items offer a guaranteed purchase price, simply write your bid number on the "BUY IT NOW" line. The bidding on that item is then concluded and no one may bid above your guaranteed purchase bid.

You may bid on any item in any silent auction section until it is announced that the silent auction is closed or until 7:30 p.m., whichever is later. A silent auction official will circle the top bid number and amount at the completion of the auction. At checkout, if your bid number is listed among the successful bidder numbers, you may claim your auction items at the checkout counter after 10 p.m. To see if you have won, signs will be posted outside the ballroom doors.

Please allow our volunteers the time they need to calculate all of the auction items. We want to ensure accuracy and the time allotted is necessary to do so. Please do not remove auction items from the tables. Items will be available at auction checkout after 10 p.m.

Live Auction Rules

The live auction will take place during the dinner and continue without interruption until all items have been purchased.

Bidders remain seated. To enter a bid, the bidder raises his/her bid number, thus directing a signal to the auctioneer or to the spotter, whose job it is to relay bids to the auctioneer.

The highest bidder acknowledged by the auctioneer shall be the purchaser. In the event of any dispute between two bidders, the auctioneer shall have the sole and final discretion either to determine the successful bidder or to re-offer the item in dispute.

If the auctioneer determines that an opening bid is not commensurate with the value of the article offered, he may reject the same and withdraw the item from the sale.

On the "fall of the auctioneer's hammer," title to the item will pass to the highest bidder.

About Us

CaringMatters (founded in 1989 as Hospice Caring, Inc.) provides compassionate social support services, without charge, through a trained volunteer network, serving children, adults and families facing life-threatening illness and experiencing grief. The organization's community and professional education programs increase awareness and action around end-of-life issues, advance care planning and grief.

Our small staff and a large volunteer network provides non-medical services, without charge, none of which are covered by Medicare or other insurance. Our direct services are delivered by screened and trained volunteers, all of whom have completed at least three full days of specialized training.

CaringMatters has been awarded the Maryland Nonprofits Seal of Excellence and has been named by the Catalogue of Philanthropy as one of the best small non-profit organizations in the Washington, D.C. area.

Our Mission

CaringMatters provides social supports and community education so no one dies or grieves alone.

Our Vision

CaringMatters envisions a community that accepts death as a part of life; where the processes of dying and grieving are embraced without stigma; where everyone has access to support services without charge; and where no one dies or grieves alone.

Our Values:

- Presence, caring, and compassion
- Quality services that honor personal choices
- Culturally competent support, accessible to all

Our Service Area

We serve all of Montgomery County, Maryland. The Volunteer Helping Hands program serves patients wherever they reside (private homes, assisted living facilities, nursing homes, etc). Bereavement groups and educational sessions are held in schools and other convenient locations throughout the community.

Programs

Volunteer Helping Hands (Caregiving)

Volunteer Helping Hands, CaringMatters' patient and family program, offers short-term, practical, social and emotional support for people of all ages with a serious illness and no reasonable prospect of a cure. Services include, but are not limited to: companionship and emotional support, assistance with household tasks, respite care, patient advocacy, and limited transportation to appointments. Trained program volunteers serve patients wherever they reside (private homes, assisted living facilities, nursing homes, etc). CaringMatters is licensed by the state of Maryland as a limited hospice care program. While we do not provide medical services, we supplement medical hospice and also support patients who are still pursuing curative treatment.

Bereavement Services

Adult Support Groups

Bereavement support groups, facilitated by trained volunteers, allow participants to meet others who are also grieving, share their stories, and learn from one another. Specialized groups include adult child loss, parent loss, sibling or friend loss, spousal loss, and suicide loss. Additional groups are formed based on community need.

Good Grief Clubs for Children

These seven- week support groups help children in grades K-12 explore their feelings, develop healthy coping strategies, and find comfort and safety in learning that they are not alone. These groups are facilitated by trained CaringMatters volunteers in partnership Montgomery County Schools, independent schools, and other community-based organizations.

Family Nights

CaringMatters' Family Nights are designed for families who have experienced the death of a loved one. Each workshop is held approximately one week prior to a major holiday, so that families can learn coping tools, plan for how they will handle celebrations, and mark the absence of their loved one(s). Activities facilitated by trained volunteers encourage parents and children to create something together to take home, as a way to continue conversations about their loved ones and to help keep their memories alive.

Camp Erin© Montgomery County

This overnight weekend camp for grieving children is part of a national network of Camp Erin programs. The camp serves children and teens ages 6-17 and offers age-appropriate discussions and creative, fun-filled activities designed to help children share their feelings with peers who have had similar experiences. Camp Erin Montgomery County is a partnership between CaringMatters, the Eluna Network, and Bar-T, a premier childcare provider.

Community Education

Our Community Education program works to raise awareness and better equip people to address end-of-life and grief-related issues. We host educational sessions, offer continuing education (CEU) workshops for professionals, and facilitate dialogue on relevant topics in the community. CaringMatters also provides specialized workshops on Advance Care Planning, including resources to complete an advance directive, a plan for end-of-life care and the appointment of a health care agent.

Strategic Goal: This three year strategic framework (fiscal years 2020-2022), approved by the Board of Directors on September 11, 2019, serves as a blueprint for the future of CaringMatters. Annual performance measures will be used to monitor progress and identify necessary adjustments to the plan.

Sustain funding to expand programs and perpetuate organizational longevity.



Ensure sufficient number of highly-qualified staff to manage volunteer workforce for the delivery of exemplary programs, meeting desired outcomes.



Recruit, train and nurture culturally diverse and linguistically appropriate volunteers to deliver services and support the organization.



Increase visibility to serve all Montgomery County residents, recruit volunteers, develop partnerships and increase donations.



Enhance electronic database and management reporting systems for programmatic and financial decision-making and accountability.

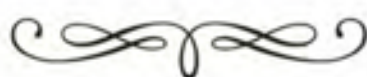

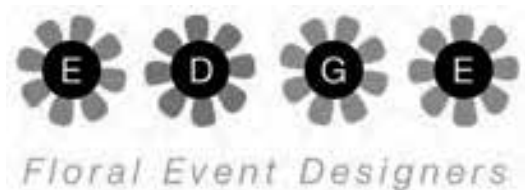
